Lagoon Maintenance

For those living on a lagoon... it is the homeowner's responsibility to ensure the grass is cut up to the lagoon, per our covenants. Please ensure this is done... thank you in advance....

Mailboxes

Many of you have already purchased new mailboxes and posts... or you have painted them and spruced them up to ensure that they meet all HOA requirements and standards... thus ensuring our neighborhood continues to look upscale ...

Many of you have put on new copper tops.... This is *the only* approved item for on top of the post....

Thank you to all of you who have done this to date!!!!

Still... about 70 mailboxes are not yet up to code...

They might be rusty, bent, or have a non-regulation mailbox. Posts may not be painted, or they are crooked... or on some, the top part of the post (the wooden post cap) is splintered or worn out...

All regulation mailboxes and posts can be obtained from Mahoney Mailbox (843-884-9053). Paint to be used is Charleston Green gloss latex (available at Royal Hardware on Coleman)... for further details, please see Seasidefarms.org website... go to documents/May 2014 newsletter.

If you have received notification about your mailbox- you will have 30 days to fix it before receiving a fine.
