It's Spring Clean-Up Time...

OUR YARDS

It's time for all of us to ensure that our yards are spruced up!

- Dead fronds should be cut from all palm trees... front and back (only exceptions are the Canary Island and Washington Palms (these two species should not be cut back until the green has grown out of the fronds))
- Ensure that trees, shrubbery and beds are trimmed, pruned and cleaned, both in front and back yards
- Mulch or pine straw is put in and grass is being kept mowed
- Bare spots in grass should be treated and fertilized for new growth
- As you spruce up your yards (or your landscaping folks do) –debris or trimmings or bags are not to be put out on the street until **5:00 Monday evening** for Tues morning pick-up
- No neighbor is to put any of their debris or trimmings on another neighbor's property. Please be respectful of each other. Thank you in advance!

Architectural Review Board (ARB) Updated Exterior Home Improvements Guidelines

- Brick houses may not be painted or changed by any process. They must be kept in their original state
- Fence guidelines have been updated to address Cathedral Oaks requests
- Approval of projects by the ARB, are effective for 6 months from date of the approval letter. Projects not started within 6 months must be resubmitted to the ARB
